Program Introduction

Thank you for your interest in our Eternal Spring Program (ESP). Our gestational surrogacy program takes place in Guatemala City, Guatemala. We have organized all professional services needed for you to create family in one place. We serve clients from many nationalities and most embassies are located in Guatemala City. We have cost and legal advantage than many popular surrogacy venues. We do not discriminate on age, being single, and LGBT welcome here.

We use our own staff and professional collaborators such as fertility physicians, psychologists, and lawyers. Our standard surrogacy packages include everything; lawyers, IVF clinics, GC, her expenses, egg donor, testing laboratories, hospital, transportation and translation, passport fees, birth certificate fees, etc., Our clinics do accept shipments of gametes or embryos from most global locations. Gender selection of embryos is permitted.

We have egg donors and GCs ready all the time, so there are no waiting lists





Eight General Features We Do

- 1) We introduce you to one or more GCs
- 2) We support and manage your GC throughout the journey.
- 3) We will endeavor to make the journey as smooth and pleasant as possible.
- 4) We provide *in vitro* fertilization (IVF) and additional fertility work through our associate IVF clinics.
- 5) We will present our local "beautiful" egg donors.
- 6) We provide all legal contracts and lawyers for your contract with GC.
- 7) We provide and legally manage the change in GCs parental rights.
- 8) We assist you with baby's papers such as birth certificate, passports and legal documentation for support. All the procedures done in Guatemala (legal evidence and clinical certifications of all the procedures) are translated into English.

How We Screen Egg Donors And GCs

Our process to screen egg donors and GCs is the same used by any professional and experienced organization. All of our GCs have to be mothers with uncomplicated pregnancies and birth. Our physicians complete a medical record review as a first step. The GCs are tested for any infectious diseases and drugs. They also undergo a physical exam with focus on reproductive health. A psychologist will conduct an evaluation of the GC candidate. All of our GCs come to our program through past GCs. These women are usually relatives or friends of current or past GCs. This allows us to reduce risk of undesirable social behavior.

Egg donors undergo similar evaluation as the GCs, but do not have to be mothers. A deeper history of family health is collected on egg donors.

Our most popular offering includes a local egg donor, PGT-A testing and up to three embryo transfers. We do offer free consultations with a doctor and family law lawyer throughout your journey.

Specific Items Provided: ESP Packages

GC and local egg donor inclusions

Recruitment, background check Medical records review Psychological screening (battery and clinical examination) Medical screen (physical and blood work) GC monthly compensation starting when she signs with IP(s) GC lump sum payment for the journey Maternity clothes Housing allowance Transportation and accompaniment to all medical appointments and birth Local egg donor compensation*

Obstetrics, Hospital and GC Health:

All prenatal care appointments, at least monthly visit with obstetrics/gynecology physician

Birth at a local private hospital, includes C-section if needed Up to three days stay at hospital Amniocentesis if medically warranted

Fertility Clinic:

Sperm collection and freezing (one-year storage included) Egg retrieval from IM or local donor *In Vitro* fertilization with ICSI, if necessary Embryo freezing and storage for one year Embryo transfer(s) – package dependent All hormones for the egg donor and the GC All blood tests to monitor pre and post embryo transfer monitoring Genetic testing of up to ten embryos (PGT-A)*

Legal:

Legal agreement between IP(s) and GC Birth certificate, with sworn translation into English Legal change in child custody from GC/Intended father (IF) to IF only Guatemalan person (baby) registration with RENAP Passport(s) and or travel papers for baby

Local:

Assistance with hotel and travel arrangements in Guatemala Transportation to medical appointments and translation in meetings Airport pickup and return

Beyond one year of embryo and/or gamete storage (\$500 after first year)

Intended mother or husband (gay) adoption in other country, but we help

IF or GC DNA testing if needed (estimated at \$900 per person)

Not included:

Shipping fees for embryos or gametes from other country Twins, GC gets \$4,000 more with twins

Extended hospital stays due to complications Neonatal hospital care for baby Genetic testing of embryos (apart from PGT-A*) Testicular sperm extraction Extra embryo transfers (\$3000) beyond your package

Neonatal intensive care (estimated at \$500 per day)



Payment Milestones

You only pay for services rendered. You are not billed for anything not used.

Note: Once you sign our agreement payment is due before we start the process. If you cancel the contract before embryo transfer, all unused funds will be returned minus \$5000 USD and expenses.

Payment due at signing of 47% of the total, lawyers, GC payments, screening costs (medical, psychological, background)

Second payment: due at 12 weeks of pregnancy 15% of total, covers GC costs,

Third payment: due at 30 weeks of pregnancy 20% of total, GC pay, OBGYN

Final payment: at birth is 18% of the costs, hospital, legal papers

Free consultations are offered with a doctor and a family law lawyer.
